

The Madison County Board of Commissioners met in regular session on Tuesday, August 09, 2016 at 7:00 p.m. at A-B Tech, Madison Campus, Marshall, NC 28753.

In attendance were Chairman Wayne Brigman, Vice-Chairman Norris Gentry, Commissioner Bill Briggs, Commissioner Clayton Rice, County Manager Forrest Gilliam, Attorney Donny Laws, and Clerk Darlyne Rhinehart. Absent was Commissioner Matt Wechtel.

I.
